Examination Procedure

Assessment for CDCS consists of a three-hour multiplechoice (paper based) examination, designed to test your knowledge and its application to practical situations.

The examination is split into two sections:

- Section A 83 multiple-choice questions
- Section B 37 multiple-choice questions based on case studies (in-basket exercises), analysisquestions and simulation exercises.

Overall the examination comprises 120 questions. To pass you must achieve the required pass mark in Section B as well as achieve the overall pass mark. The pass mark for CDCS may vary from year to year to maintain an equivalent level of performance to achieve a pass. As a guide, the pass mark is usually in the region of 70%.
